Data Protection

We operate and are registered as David Dale Gallery and Studios in accordance with current data protection legislation.

What do we collect from you?

We store your full name, email address and post code when you sign up to our mailing list online or in the gallery and when you make an enquiry about studios but only when data storage is requested and agreed. We do not collect any sensitive data such as information about health, race, religion and political opinions. We do collect details of gender and age for evaluative purposes for funding reports, however this is collected completely anonymously. Website
